Pursuant to the Order of Madam Recorder Winnie Tam SC herein dated the 22nd day of May 2023 whereby it was ordered that judgment as hereinafter provided be entered for the Petitioner against the 1st and 2nd Respondents

IT IS ADJUDGED THAT:-

1. The 1st Respondent shall not, without leave of the court, for the period of 8 years:

- (a) be, or continue to be, a director, liquidator, receiver or manager of the property or business, of any listed or unlisted company in Hong Kong; and
 - (b) in any event, whether directly or indirectly, be concerned, or take part, in the management of any listed or unlisted company in Hong Kong;
2. The 2nd Respondent shall not, without leave of the court, for the period of 5 years:
- (a) be, or continue to be, a director, liquidator, receiver or manager of the property or business, of any listed or unlisted company in Hong Kong; and
 - (b) in any event, whether directly or indirectly, be concerned, or take part, in the management of any listed or unlisted company in Hong Kong; and
3. The 1st and 2nd Respondents do pay the Petitioner's costs in these proceedings, with certificate for two counsel, to be taxed if not agreed.
